TERMS OF USE (Version July 2015)
of single case IDB data via the password restricted access at

The European Injury Database contains anonymous personal data on accidents and injuries. The data is provided by data suppliers in participating countries (IDB Network Members) for purposes of preventive medicine, public health research, and the implementation of the Council Recommendation on Injury Prevention from May 31, 2007. The European Injury Database is hosted by DG Sanco C2 (IDB data controller). These terms of use are issued by the EuroSafe as Network Co-ordinator on behalf of the IDB Network Members.

According to the Data Protection Directive 95/46/EC of the European Parliament and the Council of 24 October 1995 on the protection of individuals with regard to the processing and use of personal data and on the free movement of such data, as well as to internal rules of the Commission:

The user of the European Injury Database agrees to the following terms and conditions:

- Single-record data is to be used for internal purposes only. The user will not give access to single-record data to a third party.
- Single-record data shall not be published or disseminated to the public, neither to a third party.
- The user will not link IDB data to other information in order to identify natural persons.
- The user may use the data only for the general purpose of research or analyses with the goal of deriving general findings to enhance safety and prevent injuries and for the specific purpose as described in the request for a research access to single-record-data.
- Whenever publishing any results of such research or analyses, the user will indicate the source ("Source: EU Injury Database – The IDB Network & the EU Commission, DG Health") in text, tables, figures, and list of literature. Any publication using IDB data shall be notified to the Network-Coordinator.
- Data suppliers, network-coordinator, or data controller cannot be hold responsible for any outcome or conclusions of research and analyses.
- The analysis of the single case IDB data takes place in compliance with the national data protection legislation of the applicant's country.
- The user will use data only during the agreed period of time. Any internal copies of data will be deleted immediately after the termination of the user account.

Working together to make Europe a safer place

A temporary user account for up to 12 months can be granted only to signatories of this document. All accounts expire by the end of the current calendar year. This document is to be signed by each IDB user (physical person) and returned to the Network Co-ordinator (EuroSafe), in order for the IDB data controller (European Commission, DG Health) to create and maintain the user account.

Any breach of these Terms will result in an immediate and definitive suppression of the restricted access to the database. Any user who breached the contract carries the full responsibilities for any consequent legal act.
